The conference brought together 250 representatives from 22 Pacific Island countries including persons with disabilities from members of the Forum as well as dignitaries, mission heads, stakeholders and advocates.

The Regional Conference is held biennially however contd.

With the theme: "NOTHING WITHOUT US: Deepening partnership for an inclusive and Equitable Blue Pacific Continent for Persons with Disabilities," the 7th PRCD also provided an opportunity Organisations of Persons with Disabilities (OPDs) and Government focal points to come to the table and identify key action points as well as make commitments to the advancement in-country on the implementation of the UNCRPD as well as the SDGs.

Acknowledging the 1.7 million people in Pacific Island countries and territories persons with disabilities, are attendees once again reiterated their welcomed commitment to and the collective vision in the 2050 Strategy for the Blue Pacific Continent for a Pacific region of peace, harmony, security, social inclusion, and prosperity, that ensures all Pacific peoples, including persons with disabilities lead free, safe, healthy, and productive lives.





The participants highlighted four main thematic areas which they would focus their attention on mainly:

- (i) an Enabling environment so that the CRPD can be localised,
- (ii) building resilience through the active and equitable participation of persons with disabilities in national disaster preparedness,
- (iii) ensure that persns with disabilities are not forgotten through Inclusive programs and finally
- (iv) the setting up of a regional multistakeholder funding facility to enhance the implementation of the CRPD and SDG through collaboration and cooperation.

The 250 participants from 22 Pacific Island countries and territories, and beyond Pacific region, the representing organisations of persons with disabilities (OPDs), governments, regional organisations, multilateral organisations, disability providers, service academic institutions. non-governmental organisations, donors, and development partners from Australia, Cook Islands, Federated States of Micronesia, Fiji, French Polynesia, Indonesia, Kiribati, Nauru, New Caledonia, New Zealand, Palau, Papua New Guinea, Philippines, Republic of the Marshall Islands, Samoa, Singapore, Solomon Islands, Switzerland, Thailand, Tonga, Tuvalu, States of America United Vanuatu, at the 7th Pacific Regional Conference on Disability, held in Nadi, Fiji, from Tuesday February to Friday 3rd March 2023.

Call made for inclusion

"Include the issues of indigenous persons with disabilities as part of your advocacy efforts!"

This is the call being made by indigenous persons with disabilities from around the region following the 7th Pacific Regional Conference on Disability.

This was the collective voice of indigenous persons with disabilities from Cook Islands, Federated States of Micronesia, Fiji, French Polynesia, Kiribati, Samoa, the Solomon Islands an Tonga who called on those regional Governments, stakeholders and regional partners who have indigenous issues as one of their priority areas.

Following the Conference, the Indigenous Persons with Disabilities Committee called for better concerted efforts by all parties involved over the next two years in 6 areas of work namely:

(i) the need for Pacific Island leaders to recognize the rights of indigenous persons with disabilities through the various international conventions, (ii) ensure that there are more disability specific training and advocacy efforts geared towards heath service providers who are the service providers to indigenous persons in remote and rural areas,

(iii) the need for more attention provided to the provision of support services such as sign language interpreters, guides, etc so that persons with disabilities are not left out during the exchange of vital communication and information as work continues for the inclusion at various international level,

(iv) commitment from humanitarian partners for the provision of accessible evacuation centres,

(v) for a more concerted effort to preserve the unique Pacific cultures and traditions which are slowly eroding and finally

(vi) request for donor partners and agencies to realize the importance of achieving the rights of indigenous persons with disabilities across the Pacific region and to set aside proportions of funding towards programs and services that would help to recognize and further realize these rights as unique peoples of the region.

"Growing Strong Together" - A transformational Journey for OPDs

Growing Stronger Together, a statement coined as the title of the initiative to reflect the aspiration of this journey, aimed to lift the standard of the OPDs, improve and strengthen governance, build, and strengthened capacity, fortify our compliance and above all to reconfirm the relevance of the OPDS as NGOs operating in a very competitive and volatile environment.

Growing Stronger Together is simply improving compliance and meeting the due diligence on our donor partners. However, the process is coined for a more friendly understanding by the OPDs, that they understand what we are aiming to achieve, to build from a strength base approach, for ownership of the process built on trust and complementarity. It is our transformation journey for the next three years.

The process is a program to be carried out across the OPD members who receives core funding and project funding from PDF and extended to all OPD members of the PDF Board who do not receive core or project funding from PDF and OPD as an associate member who receives project funding from PDF.

It is to demonstrate that we are committed to improve our governance and compliance starting at the PDF OPD represented at Board level and cascading to all our OPDs full and associate members who either receives core funding and project funding. Keys Areas of assessment included governance, organisational capacity, staff capacity, compliance, policy, financial management.

This process is pivotal for members. The transformation journey for the OPD, to lift the standard of OPDs, improve compliance and have a functional efficient and effective OPDs, is a process to strengthen the OPDs for the next 3 years. While this is a due diligence process for donor funding, it is not called 'due diligence' for its donor-centric outlook, the process with the OPD is called "Growing Stronger Together" to encapsulate the essence goal of the process, of the transformational journey to lift the standard of the OPD, strengthen our governance, grow and build capacity, improve our delivery, tell our story better and improve our convening power through the Leadership training and other training.

Youths get a glimpse into disability issues

On behalf of the Pacific Disability Forum, Programme Officer Telesia Kobiti was given the opportunity to attend the Youth APFSD. The Youth APFSD happens a week prior to the APFSD as a preparatory meeting for youths from the Asia Pacific region that will be attending the actual Asia Pacific Forum on Sustainable Development (APFSD).

The youth forum brought together 400 young people, activities, and advocates from 36 countries across the Asia-Pacific region. The forum was held in hybrid modality, from 18th - 20th March 2023 in Bangkok, Thailand bringing together diverse individuals aged between 13 - 30. These youths represented youth-led and feminist organizations, organizations of persons with disabilities, changemakers, social entrepreneurs, activists, and students.

The youths spoke to the SDG goals in review:

- SDG 6: Clean Water and Sanitation
- SDG 7: Affordable and Clean Energy
- SDG 9: Industry, Innovation and Infrastructure
- SDG 11: Sustainable Cities and Communities
- SDG 17: Partnerships for the Goals

The youths also highlighted other goals such as SDG 3 on Health and Wellbeing, SDG 5 on Gender Equality and SDG 13 on Climate Action. The youth forum offered a safe space for young leaders to come together and share about youth led initiatives in their countries and subregions to achieve sustainable development. Over the course of the 3 days, different youths were chosen as panelists and speak to the goals in the review.

Programme Telesia Kobiti was chosen to speak on the final day of the forum on SDG 9.

Telesia shared with other youths PDF's work on Access Auditing and the most recent audit that was done with the Australia Pacific Training Coalition (APTC) whereby 4 youths with disabilities were trained and carry out the audits of the 5 APTC Premises.

The youths were trained on using the audit toolkit, carried out the audit, reported and shared their findings with the APTC Head and GESI team.

Additionally, it was also shared how youths with disabilities can also be agents of change in their communities.



Disability giant called to rest

The Disability Sector in the region has lost a giant of a man.

These are the parting words of the CEO Mr. Setareki Macanawai as he bid farewell to Joshko Wakaniyasi.

"Joshko has run the race and leaves a legacy that we are left to follow after. I acknowledge all of you for spending some time here with us before we say our last farewell and bid our last respects to this giant of a man."

Joshko Wakaniyasi was the Manager for Inclusive Development at the Pacific Disability Forum and prior to this, he was the Executive Director of Spinal Injuries Association of Fiji.

Joshko as he was affectionately known spent 16 years in the disability sector, focusing on improving the lives of people living with spinal injury and physical impairment then working closely with stakeholders on numerous projects and policies to improve the lives of persons with disabilities.

Joshko was laid to rest in March of this year after a short illness. He played an important role in disability advocacy and inclusion by being on the steering committee of United Nations Volunteers, a council member of Fiji National Council of Disabled Persons, a board member of Fiji Council of Social Services and a working group member of the Sustainable Goals Development Fund, amongst others.

Joshko is survived by his two siblings.
